

## Tariff Update



If you've watched the news lately, chances are you are already well aware of the latest increase on Tariffs for \$200 Billion in Chinese goods from 10% up to 25% now. Tariffs are a tax on imports typically charged as a percentage of the transaction price that a buyer pays. In the case of casters, this means any imported component or product now has an additional 25% surcharge on it which is collected by U.S. customs and border protection at the port of entry. This simply means any business importing products included in this list of \$200 billion must now pay an additional 15% more (Was 10%, is now 25%) than was formerly paid just one month ago in order to land these products in the U.S.


#### So what's different about the latest increase?

The initial 10% tariff was levied on products being received into port effective that day and moving forward. This had an immediate effect on goods coming in which would then work through inventory and make its way to consumers. The latest changes, however, are effective on goods shipped from overseas after May 10th. This means that before any changes actually affect consumers the products will need to make the journey to the states, be received, have the tariffs paid, and then be put into inventory by the receiving company. That could range from several weeks to several months before this additional 15% will hit the bottom line for the caster industry depending on how much inventory is on hand of existing products and when products were most recently shipped from overseas. That's good news for you as that means these changes will not immediately take effect as they have previously and there are several weeks, or even months, to prepare for the impact.

RWM is not passing any Tariff increases until they actually hit inventory for sale. If you are already receiving increases from industry suppliers, you may want to have them take a second look.
